Flexible billing and statement options

Collective statement*: centralised statement with a balance overview for all cards plus an information statement showing the individual transactions for internal expense accounting purposes.
Individual statement*: separate monthly statement sent directly to the cardholder and/or copied to the company.



Company travel card*

Designate the card number of a Corporate Card for use by the travel office through which you regularly book employee business trips. The costs incurred for flight tickets and hotel arrangements, etc. will then be shown on the statement for this credit card.



Company shopping card*

When placing orders for office materials, etc., your purchasing department can simply quote the card number to the supplier – that way you always have an up-to-date and detailed overview of all company purchases.

* Travel and shopping cards are non-personal cards, i.e. they are not issued in the name of a given cardholder. These are single-purpose cards and can only be used for transactions made via the Internet or by phone. Compliance with the obligation to take due care (Art. 3 of the General Terms and Conditions) is therefore particularly important.

For employees who travel frequently in euro or US dollar currency areas, it pays to have a Corporate Card Gold denominated in the corresponding currency. It saves you the cost of currency conversion fees and protects against exchange rate fluctuations.

The only requirement is that you have a Swiss bank account, preferably in the same currency as your card.

Insurance cover*

Travel accident insurance	Compensation in the event of death and disability as well as assumption of transport and rescue costs, up to CHF 600 000 per event and per person.
Trip interruption insurance	Assumption of costs in the event that the business trip is interrupted, cancelled or extended, up to CHF 10 000 per event and per person.
Medical travel assistance	Unlimited assumption of costs for return trip, return transport and repatriation as well as assumption of costs for search and rescue and for medical treatment, up to CHF 500 000 per event and per person.
Luggage insurance	Assumption of costs in the event of theft, loss or damage as well as for the purchase of essential clothing and toiletries in case of delay, up to CHF 5 000 per event and per person.
Trip cancellation insurance	Assumption of costs for cancellation and any rebooking, up to CHF 10 000 per event and per person.
Hire car insurance	Damage and theft are covered for up to CHF 100 000, and the excess payable for fully comprehensive hire car insurance is covered for up to CHF 10 000 per event.
Corporate liability waiver	If the corporate credit card happens to be used for illegal purposes, your company is also insured for card misuse for up to CHF 50 000 per event and per card.

Additional services

Company bonus on card purchases and cash withdrawals (per company master account)	From CHF 10 000 / EUR/USD 7 500 annual turnover: annual fee for all cards reduced by half. From CHF 20 000 / EUR/USD 15 000 annual turnover: annual fee for all cards waived (in the following year).
Turnover bonus on card purchases and cash withdrawals (per card, excl. fees)	From CHF 10 000 / EUR/USD 7 500 annual turnover: annual card fee reduced by half. From CHF 20 000 / EUR/USD 15 000 annual turnover: annual card fee waived (in the following year).
Hertz car hire discounts	Pay with your credit card and take advantage of a discount and other benefits.
